Dear Mr. Washburn:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended revising the label in compliance with PR notice 2001-1 and 2001-6 is acceptable, provided you make the following label changes:

- 1. Based on previous labels and Confidential Statement of Formula for this product, you product contains petroleum distillate. Therefore revise the Inert ingredient statement by adding an asterisk and a footnote that read *contains petroleum distillates".
- 2. Based on the amount of petroleum distillates, make the following revisions to the First Aid Statement.
 - a. Revise if "SWALLOWED" to read:

IF SWALLOWED: Immediately call a poison control center or doctor. Do not induce unless told to do so by a poison control center or doctor. Do not give any liquid to the person.

Do not give anything by mouth to an unconscious person.

However, If registrant have data to show there is benefit in drinking water or milk after ingesting their product(s), they may submit alternate wording via amendment.

b. Add the note to Physician to the bottom of the chart to read: "Contains petroleum distillate-vomiting may cause aspiration pneumonia."

- 3. Under the Hazards to Human and Domestic Animals, delete the statements "For eyes, flush with plenty of water. Get medical attention of irritation persists." These statements are addressed in the First Aid statements.
- 4. Under Storage and Disposal, change "so not" to read: "Do Not"

The Confidential Statement of Formula dated 10/6/93 indicated that your product contains a solvent that no longer is acceptable in pesticide formulations. Please submit a revised Confidential statement of Formula that addresses our concerns.

A stamped copy of the label is enclosed for your records. Submit three copies of revised final printed labeling prior to releasing product for shipment.

Application should be made in the late evening when the insects area at rest. Hold can upright. Remove cap. Point valve opening away from face.

Outdoors: (Wasps, Hornets, Yellowjackets) With wind at back, aim at nests in trees, bushes, under leaves, chimneys, cracks and crevices.

Indoors: (Bees) Bees are beneficial insects. Application should be made only for bees that invade buildings. Aim directly at nest under rafters, in wall voids, attics, warehouses.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. STORAGE: Store in cool, dry place away from heat or open flame. DISPOSAL: so not Puncture or Incinerate! If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEANUP for disposal instructions.
