 - b. Revise the front panel claim for Sweet Itch vectors to read as follows: "Kills and repels members of the *Culicoidae* and *Simuliidae*, vectors that may cause Sweet Itch, for up to two weeks."
 - c. Delete the front panel claim "Approved for use with Ultrashield® Brand Residual Insecticide & Repellent". Use of the term "approved" and the prominent placement of this statement on the front panel may imply EPA approval of this product combination. If you wish, you may revise this statement and move it to a less prominent position within the Directions for Use. A statement such as "May be used with Ultrashield® Brand Residual Insecticide & Repellent" would be acceptable, provided this is a registered product for use on horses. [NOTE: We could not find a record of this product name in our database.]

d. Move the following statements from the paragraph under Hazards to Humans and Domestic Animals to the Directions for Use:

"Sensitivities can occur after using ANY pesticide product for animals. If signs of sensitivity occur wash area with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately."

- e. Under the Directions for Use, change "Do not use on horses intended for food use" to read "Do not use on horses intended for slaughter."
- f. In step 3 of the application directions, add "front of the knee" in parentheses after the terminology "dorsum of the carpus".
- g. In step 4 of the application directions, add "behind the hock" in parentheses after the terminology "plantar surface of the tarsus".
- h. Delete the paragraph at the bottom of page 3 regarding the symptoms and etiology of Sweet Itch. This type of veterinary/medical information is not permitted on pesticide labels, since we don't have the expertise to evaluate its correctness. If you wish, you may add a statement referring users to a veterinarian for Sweet Itch symptomology and/or etiology information.
- 3. Please submit two (2) copies of your final printed label before you release the product for shipment. Please refer to the A-79 enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

- 2] streak 1 cc on the forehead under the forelock; taking care to avoid the eyes and mucous membranes
- 3) spot 1 cc over the dorsum of the carpus on each of the front legs [2 cc total]
- 4] spot 1 cc over the plantar surface of the tarsus on each of the hind legs [2 cc in total]

Place empty applicator in trash

Do not reapply for 14 days.

The symptoms of Sweet Itch [also known as summer eczema and summer seasonal recurrent dermatitis] include severe pruritus, hair loss, skin thickening and flaky dandruff. Exudative dermatitis [weeping sores], sometimes with a yellow crust of dried serum may occur. The top of the tail and the mane are the most commonly affected areas although other areas including the neck, withers, hips, ears and forehead may also be affected. The cause of sweet itch is feeding on the horse by certain Culicoid midges and Simulid blackflies whereby the horses develop a hypersensitive reaction to the saliva of the female insects.
