

Ready to Use. Do Not Dilute. Take a cutting from the plant. Pour Wood's Ready To Use Solution into a small container. Dip the stem into the solution to the desired rooting depth. Make sure at least one node is without the leaf is submerged into the compound. (See illustrations) Place the treated cutting into moist propagating media.

For propagating areas without an automatic watering/humidity control system, try to keep your cuttings in a climate bottom heated to 70-75 degrees F, with high humidity, and where the air is circulating. When propagating a small amount of cuttings use a cutting tray with a clear cover. Mist plants with water once or twice a day or use Wood's Ready To Use Anti Wilt.

#### STORAGE AND DISPOSAL

STORAGE: Store at room temperatures. Keep out of direct sunlight. Place in a locked storage area, Avoid contamination of feed or foodstuffs. Store in original container.

DISPOSAL: Do not re-use this container. Rinse thoroughly and securely wrap in several layers of newspaper and discard in the trash.
