The amended label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act as amended is acceptable provided the following changes are made:

1. On page 2, delete the header "Statement of Practical Treatment"
2. On page 3, include the following information: "EPA Establishment No. _____"

One copy of the label stamped "Accepted with comments" is enclosed for your records. Please submit one copy of the final printed label that incorporates the required changes before the product is released for shipment.

The Agency has completed the technical review of the revised Basic Confidential Statement of Formula (CSF) dated 7/24/04 that was submitted with this amendment and is unable to approve this revised CSF because we do not have information on the composition of several of the inert ingredients. A copy of the Product Chemistry Review D306601 dated 8/25/04 is enclosed for your records. For each of the inert ingredients listed in the Confidential Appendix to this Product Chemistry Review, please have the manufacturer submit the following information to the Agency:

STATEMENT OF PRACTICAL TREATMENT

FIRST AID	
If on Skin or Clothing:	<ul style="list-style-type: none"> • Take off contaminated clothing. • Rinse skin immediately with plenty of water for 15-20 minutes. • Call poison control center or doctor for treatment.
If in Eyes:	<ul style="list-style-type: none"> • Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. • Call poison control center or doctor for treatment advice.

Ready to Use. Do Not Dilute. *Take a cutting from the plant. Pour Vita Grow Ready To Use Solution into a small container. Dip the stem into the solution to the desired rooting depth. Make sure at least one node is without the leaf is submerged into the compound for 5 to 15 seconds for softwood and 10 to 30 seconds for hardwood. (See illustrations) Place the treated cutting into moist propagating media.*

For propagating areas without an automatic watering/humidity control system, try to keep your cuttings in a climate bottom heated to 70-75 degrees F, with high humidity, and where the air is circulating. When propagating a small amount of cuttings use a cutting tray with a clear cover. Mist plants with water once or twice a day or use Vita Grow Ready To Use Anti Wilt.
