

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

AGRICULTURAL USE REQUIREMENTS

Do not apply this product in a way that will contact workers or other persons, either directly or through drift. Only protected handlers may be in the area during application.

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR 170. This standard contains requirements for the protection of agricultural workers on farms, forests, nurseries and greenhouses, and handlers of agricultural pesticides. *Tobacco: For repelling Aphids, Armyworms, Budworms, Mites, Moths, Thrips and Whiteflies. *Not for use in California

MIXING DIRECTIONS: Shake container well or stir contents thoroughly before adding Envirepel to the spray tank DH level must be adjusted to a maximum of 6.0 before adding Envirepel to the spray tank. Optimum pH range for tank mix before mixing Envirepel is 5.5 to 6.0. Recommended buffering agents are citric acid, acetic acid, phosphoric acid or alliphatic polycarboxylate-type materials. Do not buffer with propionic acid or similar products that affect biologically active products. After mixing, agitate spray tank mix before and during application to prevent settling of product.

TANK MIXING WITH OTHER PRODUCTS: Mix a solution of Envirence with the products to be tank mixed at their recommended label rates in a glass container to determine if there is any separation. It is strongly recommended to try a small test plot if new combinations of products are being used for the first time.

APPLICATION TIMING AND PEST PRESSURE: When using Envirepel the optimum pest pressure to start application is 0% to 5%. If tank mixing Envirepel with other pesticides, use the recommended label rates of the other pesticides until exact tank mixed product performance is determined. Repeat application timing should be between 8 to 14 days, and determined by field scouting reports of pest pressure, plant nutrition and temperature. Do not make more than 20 applications of Envirepel per each growing season. Do not apply Envirepel within 12 hours of crop harvest.

SPRAY TEMPERATURE: The optimum temperature range to apply Envirepel is between 70°F (21°C) and 90°F (32.2°C). Minimum recommended application temperature is 50°F (10°C). Maximum recommended application temperature is 100°F (37.7°C). For applications above 100°F (37.7°C) higher application spray rates (more than 40 gallons per acre) are recommended after there has been a minimum of a 15°F drop in air temperature from maximum daytime temperature.

SPRAY ADJUVANTS: Envirepel should not be used with dormant spray oils, heavy oils, spreader-stickers or surfactants that will coat the surface of the plant foliage and prevent absorption of the product. Silicone based or non-ionic surfactants are strongly recommended to increase product coverage and absorption. If Envirepet is not rapidly absorbed by the foliage it will not be effective.

APPLICATION RATES: Envirepel is designed to be used from 10 to 32 ounces [0.0625 to 0.2 lb. of Garlie Juice] per acre. Tank Mix Application Rates: By Air: 2 to 15 gallons per acre; By Ground Rig: 3 to 135 gallons per acre. [California Tank Mix Application Rates: Apply at 3 to 135 gallons per acre for row, field, vine and orchard corps.] Do not spray to the point of runoff! Spray tank pH level must be adjusted to a maximum of 6.0 prior to adding any chemicals. Greenhouse applications using overhead watering systems should use one pint to one quart [in California, one pint] of Envirepel per 100 gallons of buffered water applied.

APPLICATION METHODS: Envirepel can be applied using conventional application equipment, with little or no change to the operation of the equipment. Aerial or ground rigs are the preferred methods. Do not apply this product through any type of irrigation system.

POLLINATION WARNING: MAY REPEL BEES: Envirepel is an insect repellent and may repel bees. Do not apply Envirepel less than three days prior to pollination.

RAIN TIMING: Do not apply if rain is forecasted or overhead watering is to occur within 12 hours.
