CARPETS: Apply to dry carpet only. Apply directly to carpets where pets frequently traffic or sleep at the rate of one pound per 100 square feet (31.5 mg/sq. in.). In other areas, you may apply at the rate of one pound per 200 sq. feet (16 mg/sq. in.). Work product to the base of the carpet pile with a broom or rug rake, or use approved grooming equipment. Visible product remaining after application must be removed by further grooming or vacuuming. Allow three to five weeks for maximum flea control. Reapply as necessary. Note: If high adult flea population makes it desirable, apply a pesticide designed to kill adult fleas before or in conjunction with this product.

UPHOLSTERY: Remove loose cushions. Apply with approved applicator along creases and into comers and furniture wells. Do not apply to exposed fabric. Any powder visible after application must be removed.
