DANGER

STORAGE AND HANDLING

Surcide G-50 solutions are incompatible with many commonly used materials of construction such as steel, galvanized iron, aluminum, tin and zinc. These solutions can be stored and handled in baked phenolic-lined steel, polyethylene, stainless steel, or reinforced epoxy-plastic equipment. This product freezes at about -6°F (-21°C). Therefore, unless the storage tank is inside or underground, heating and insulation may be required. If heating is needed, exposure to high temperatures should be avoided. For short storage times (up to about 1 month), temperatures of up to 100°F (37.8°C) can be tolerated but the preferred maximum storage temperature is about 80°F (26.7°C). A stainless steel centrifugal pump is suggested for transfer service. Spiral wound stainless steel with TEFLON^(R) is suitable for gaskets and packing.
