The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the above referenced product in connection with the pyrethrin and pbo RED(s), and has concluded that your submission is acceptable.

NOTE: This product is not being reregistered under sections 3(c)5 and 4(g) of FIFRA at this time.

Please be reminded that 40 CFR Part 156.140(a)(4) requires that a batch code, lot number, or other code identifying the batch of the pesticide distributed and sold be placed on non-refillable containers. The code may appear either on the label or durably marked on the container itself, and can be added by non-notification per PRN 98-10.

A copy of your label stamped "Accepted" is enclosed for the subject product. Products shipped after 12 months from the date of this amendment or the next printing of the label whichever occurs first, must bear the new revised label. Your release for shipment of the product bearing the amended label constitutes acceptance of these conditions. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e).

Davis Dip and Spray[™] is a flea and tick dip or spray, controls fleas and ticks when used as an environmental surface spray and provides protection against flea and tick reinfestation.

PRECAUTIONARY STATEMENTS

Hazards to Humans and Domestic Animals WARNING

HUMANS: WARNING. Causes substantial but temporary eye injury. Do not get in eyes or on clothing. Harmful if swallowed. Wear protective eyewear (goggles or face shield). Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove and wash contaminated clothing before reuse.

ANIMALS: Do not use on dogs or cats under twelve (12) weeks old. Consult a veterinarian before using this product on medicated, debilitated, aged, pregnant or nursing animals. FIRST AID

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

READ ENTIRE LABEL BEFORE EACH USE

For Surface Spray Use: Except when applying to pets, do not allow adults, children, or pets to enter until sprays have dried. Except when applying to pets, do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Remove pets, birds, and cover fish aquariums before spraying.

For use around or near floor drains: Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

For Spray Applications to Articles (e.g. bedding): Do not wear articles to point of runoff or drip. Do not use treated article until spray has dried.

For Applications Indoors: Remove or cover exposed food and drinking water before application.

PET USE APPLIED TO USE ONLY ON DOGS OR CATS

SHAKE WELL BEFORE USING. To prepare dilutions, the concentrate should first be stirred or agitated well. Add the required amount of concentrate to water and blend thoroughly.

To Kill Fleas & Ticks on Dogs and Cats and To Obtain Protection Against Reinfestation, Follow These Steps:

1) Dilute ½ oz. (1 tbsp.) of concentrate per 1 gallon of water. For severe flea infestation, dilute 1 oz. (2 tbsp.) of concentrate per 1 gallon of water.

2) Apply directly to the animals by dipping or spraying. Dip or spray until animal's skin is wet. Do not rinse.

To Control Fleas and Ticks In The Animal's Environment, Follow These Steps:

1) Dilute 4 oz. of concentrate per 1 gallon of water.

2) Thoroughly spray infested areas, pet beds, resting quarters, nearby cracks and crevices, along and behind baseboards, moldings, window and door frames and localized areas of floor and floor coverings. Fresh bedding should be placed in animal quarters following treatment. Do Not Repeat Treatment for 7 days.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

Storage: Store in a cool area.

Pesticide Disposal and Container Handling: Nonrefillable container. Do not reuse or refill this container. **If empty:** Place in trash or offer for recycling, if available. **If partly filled**: Call your local solid waste agency for disposal instructions.
