The Agency in accordance with the Federal Fungicide and Rodenticide Act as Amended (FIFRA) has completed reviewing all of the information submitted with your application to support the reregistration of the aforementioned product in connection the **MGK 326 RED**, and have concluded that your submission is acceptable.

The Agency is in the process of developing and improving the current Efficacy Assessment Guidelines for repellent products. The Agency intends to defer the determination of any related efficacy data requirements supporting the claims that may appear on this label until these Efficacy Assessment Guidelines are complete. When the guidelines are finalized, the Agency expects to issue a Data Call-In to address the revised guidelines to all registrants with registrations for personal repellent products that have not previously submitted efficacy data sufficiently consistent with the revised guidelines.

**NOTE:** This product is not being re-registered under FIFRA Sec. 4(g) at this time.

Technology Sciences Group, Inc. should note that a notice of availability of EPA's reregistration eligibility decision (RED) documents for products containing:


- MGK 264 was published in the Federal Register July 26, 2006 (Volume 71, Number 143) Page 42381-42383).
- Pyrethrins was published in the Federal Register on July 26, 2006 (Volume 71, Number 143, Pages 42387-42389).
- Piperonyl butoxide was published in the Federal Register on July 26, 2006 (Volume 71, Number 143, Pages 42385-42386).

As a result of these REDs, additional data and/or labeling changes may be required for products containing pyrethrins and/or piperonyl butoxide, and MGK 264.

You must submit two copies of the final printed label revised in accordance with the comments listed above before the product is released for shipment under this label. 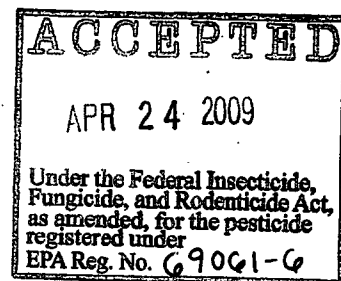

**Cats & Dogs:** Cover animals' eyes with hands. With a firm stroke to get a proper spray mist, spray head, ears, and chest until damp. With fingertips rub into face around mouth, nose and eyes. Then spray neck, middle and hind quarters, finishing with the legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On long haired dogs, rub your hand against the lay of the hair, spraying the ruffled hair directly behind the hand. make sure spray thoroughly wets ticks. **Do not reapply product for three days.**

**Puppies & Kittens:** Spray only along the back or on your fingertips and rub in.

**Horses:** use full strength to control stable flies, horse flies, deer flies, face flies, gnats and mosquitoes. Apply to face, legs, flanks, top line and other body areas commonly attacked by these flies. Do not wet horse's skin with excessive spray. After application, brush thoroughly to bring out sheen on coat. Repeat treatment as needed. Not for use on horses intended for food.

**Pet's Sleeping Quarters:** Spray around the baseboards, windows, door frames, wall cracks and local floor areas. If mosquitoes, gnats or flies are present, spray lightly into the air. Repeat as needed. The pet's's bedding should be sprayed making sure the area beneath the bedding is sprayed. After spray has dried, remove old bedding and replace with fresh bedding. Treat pets with Davis Flea & Tick Mist or one of our other registered Flea & Tick control products before allowing them to enter treated areas.

**Storage:** Store in a cool area.
