- e. Change the claim, "Protects upp to 150 hours", to read "Protects UP To 120 Hours" or submit data to back up the additional time.
- f. Have the supplier of the perfume submit the formulation of the perfume. The information must include the identification of each ingredient in the perfume and the percent or range of percents of each ingredient.
- 3. Submit one (1) copy of the revised final printed label for the record.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
