Causes moderate eye irritation. Avoid contact with eyes or clothing. Wash thoroughly with soap and water after handling. Use adequate ventilation and avoid breathing dust. For prolonged exposure to dust, use a suitable dust mask approved by NIOSH/MSHA.

- e. Delete the words "natural grade" from the statement "This natural grade product..." since statements relative to composition directly or indirectly implying to the safety of a pesticide is unacceptable.
- f. The statement, "It is a violation of Federal law to use this product in a manner inconsistent with its labeling.", must appear directly under the heading entitled Directions For Use.
- g. Under the Directions for Use revise to read the statement, "Using standard milling equipment apply two to seven pounds..." Also add the following to this section.

The moisture content of the grain or seed treated should be adjusted to no more than 12% by weight. Thoroughly mix with grain. Product may be dispensed into the grain either at the bottom of an elevator le or as it is being moved into storage by sugar or conveyor belt. Seal bin for storage. It is wise to check to status of stored grains regularly.
