

 3. Submit a revised Confidential Statement of Formula (CSF) listing the trace element oxides at 10%. Refer to the CSF submitted for 62961-1 and cover letter dated February 17, 1997.
 4. Submit two (2) copies of your final printed labeling before you release the product for shipment.
