HEALTH CARE FACILITY USES:

Sep-T-Ban™ Antimicrobial Spray is effective as a tuberculocide, bactericide, virucide, and fungicide. It kills *Mycobacterium bovis* (bovine TB), *Staphylococcus aureus* and *Pseudomonas aeruginosa* bacteria, and *Herpes simplex Type 2 and Hepatitis A viruses in 5 min. at 20C, and HIV-1 (AIDS Virus) in 5 min. at room temperature. This product is also effective against *Trichophyton mentagrophytes* (Athlete's Foot Fungus) when used as directed with a disinfection contact time of 5 minutes on hard, nonporous surfaces in bathrooms including shower stalls, floors, and glazed bathroom tiles.

For Use In Health Care Facilities: Scientifically formulated with additive germicides and patented, this product is excellent for disinfection of precleaned, hard nonporous surfaces. Safe for use on plastic, Formica, glass, or stainless steel. Will not stain clothing.

HOUSEHOLD USES:

TruClean™ Antimicrobial Disinfectant Spray not only kills bacteria, but is also effective as a tuberculocide, virucide, and fungicide. It kills *Staphylococcus aureus* (Staph) and *Mycobacterium bovis* (bovine TB) bacteria, and the Herpes simplex Type 2 virus. This product is also effective against *Trichophyton mentagrophytes* (Athlete's Foot Fungus) when used as directed with a disinfection contact time of 5 minutes on hard, nonporous surfaces in bathrooms including shower stalls, floors, and glazed bathroom tiles.

For disinfection of the following hard, nonporous precleaned surfaces: countertops, cabinets, drawer and cabinet pulls, sinks, appliances, tabletops, floors, basins, tubs, showers, glazed ceramic tile, telephones, glazed porcelain surfaces, stainless steel, chrome, and fiberglass. Any surfaces which have direct contact with food must be thoroughly rinsed with water after use of this product.

DIRECTIONS FOR USE:

(Health Care Facility):

Personal Protection: Wear disposable gloves, gowns, masks and eye protection when removing blood/body fluids from soiled surfaces.

Cleaning Procedures: Blood/body fluids must be thoroughly removed from surfaces or objects before application of SEP-T-BAN Antimicrobial Spray. A disinfectant-soaked cloth, pad or towel may be used to wipe up contaminants.

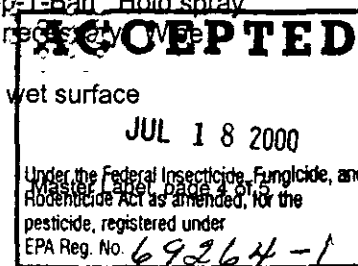
Contact Time: Make sure surface remains wet for a full 5 minutes. Re-spray if necessary.

Disposal of Infectious Materials: Blood or body fluids must be disposed of in accordance with local regulations for infectious waste disposal.

This product is not to be used as a terminal sterilant/high level disinfectant on any surface or instrument that (1) is introduced directly into the human body, either into or in contact with the bloodstream or normally sterile areas of the body, or (2) contacts intact mucous membranes but which does not ordinarily penetrate the blood barrier or otherwise enter normally sterile areas of the body. This product may be used to preclean or decontaminate critical or semi-critical medical devices prior to sterilization or high level disinfection.

For Use as a Pump Spray: Preclean surface by thoroughly removing body fluids from surfaces or objects before application of Sep-T-Ban. Hold spray bottle 6"-8" from surface and spray to wet all surfaces thoroughly. Make sure surface remains wet for a full 5 minutes. Re-spray if necessary. Wipe surface with cloth or paper towel or allow to air dry.

For Use as a Bottled Solution: Preclean surface as indicated above, apply undiluted product with cloth, sponge, or mop so as to wet surface thoroughly. Make sure surface remains wet for a full 5 minutes. Re-spray if necessary. Wipe dry or allow to air dry.



Storage and Disposal: Do not contaminate water or food by storage or disposal. Store in cool dry area away from flames, sparks or other sources of heat or ignition. Contains 65.87 wt% alcohol. If ignited, use dry chemical or CO2 extinguisher. If large quantity is spilled, dilute with water and wipe or mop dry.

Pesticide Disposal: Dilute with water and pour down sanitary drain.

Container Disposal: Empty containers may be discarded in trash after rinsing with water.

TO USE: Preclean surface. Hold spray bottle 6"-8" from surface and spray to wet all surfaces thoroughly. Make sure surface remains wet for a full 5 minutes. Re-spray if necessary. Any surfaces which have direct contact with food must be rinsed thoroughly with water after use of this product. Wipe surface with cloth or paper towel or allow to air dry.

STORAGE AND DISPOSAL: Keep out of reach of children. Do not reuse empty container. Discard in trash after rinsing with water.
