For Control Of Bees, Hornets, Wasps and Yellowjackets: It is preferable to apply this product in the evening after all the insects have returned to the nest. Aim valve opening at the nest and depress button, continuing to spray until the nest is soaked with the spray. Repeat as necessary.

#### STORAGE AND DISPOSAL

STORAGE: Store in a cool dry area away from heat or open flame.

DISPOSAL: Replace cap and discard container in trash. Do not incinerate or puncture.
