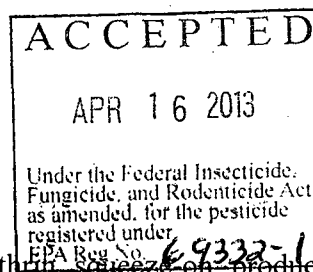

Do not apply on dogs less than 6 months old. Repeat applications may be made as necessary, but do not apply at intervals less than 7 days. Do not allow your dog to ingest this product. Use entire content of tube vial on each dog. Do not split one tube between dogs, Do not use multiple tubes on one dog. Weight your dog to be sure you are applying the right dose formulated for the weight of your dog. Separate the treated dog from all other dogs and cats for 24 hours after treatment has been applied.

onto exposed skin. If the dog's coat is subsequently wetted, such as when shampooing, the 4 week period of protection may be reduced.

**Additional precautions to protect your dog:** 1. Do not massage the drops into the dog's skin. Avoid applying to the dog's fur. 2. Do not administer any other flea control product to your dog during the 4 week period of protection. 3. Retreat after 28 days if infestation is apparent.
