3. You will make additional changes to the labeling, if necessary, as result of our reviews of the pending studies on the animal safety of etofenprox to cats and the studies related to operator exposure and dislodgeability of etofenprox from the haircoat of cats.
4. You will make the following label changes before you release the product for shipment:
 - a. Add the phrase "EPA Registration No. 69332-3 to the product label.
 - b. Under Precautionary Statement "Hazards to Humans" , add the following statement:
"Repeated exposure to etofenprox can cause skin irritation."
 - c. Remove the statement "Gentle Formula" from the label.
5. Submit three (3) copies of your final printed labeling before releasing the product for shipment.
6. The revised basic Confidential Statement of Formula dated March 25, 2004 is acceptable and is the basic CSF of Record.

You should note that if you fail to satisfy any of the conditions imposed on this registration, e.g., you fail to submit the required data by the specified deadlines or the data submitted were not generated in accordance with applicable test guidelines, EPA may issue notice to cancel this use under FIFRA 6(e).

Finally, once the required data have been submitted and evaluated, EPA will entertain an application to amend the registration of the subject product to allow unconditional use on cats.

Remove product tube [vial] from the package. Holding tube [vial] with notched end pointing up and away from the face and body, cut or tear off the narrow end at the notches. Invert the tube [vial] and use the narrow end to part the animal's hair while gently squeezing to apply to the animal's skin. Hold the animal for a few seconds to give the solution time to be absorbed into the animal's coat. When finished, wrap the tube [vial] in paper and put into the trash.

STORAGE AND DISPOSAL
