The amendment referred to above, submitted in connection with registration under FIFRA section 3(c)(7)(a), is acceptable provided that you:

- Submit and/or cite all data or other material required for registration/reregistration of your product under FIFRA section 3(c)(5) or FIFRA section 4 when the Agency requires all registrants of similar products to submit such data.
- 2. Make the labeling changes listed below before you release the product for shipment bearing the amended labeling:
- a) Reinstate in italics "Deer or Black Legged" before the pest claim Tick on the front panel of the labeling. The new efficacy data did not support a general tick claim on cats. As indicated in our August 24, 2004 letter and product performance review for a general tick control claim on cats to be considered you were to submit additional in vivo study data on cats and in vitro data with clipped hair removed from treated and untreated cats against Lone Star ticks and American dog ticks at a minimum. Only the label rate treatment should be tested because this is the rate that will be applied. The number of replicates should be at least five for the treatment. We also question the value of the additional efficacy data on fleas since it does not support the current label claims. Refer to the enclosed efficacy review.
- b) Reinstate the label text "repeated exposure to etofenprox can cause skin irritation.". We will evaluate your rationale and supporting information to remove this precautionary statement when the other data required as a condition of registration for etofenprox technical are submitted and reviewed.
- c) The other label changes are acceptable.

3. Submit two (2) copies of your final printed labeling before you release the product for shipment.
