Subject: Label Amendments PL#8208-55D EPA Reg. No. 69332-3 PL#1001 EPA Reg. No. 69332-4 Submissions dated May 19, 2006

The label amendments referred to above, submitted in connection with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA) are acceptable provide you make the following changes:

Front Panel of the Label

1. The proposed deletions are not acceptable. Retain the previously approved language.

Precautionary Statements

- Hazards to Humans: The precautionary language in this section must be retained because the product's toxicity category is category III. The statement should read: "Wash thoroughly with soap and water after handling and also before eating, drinking, chewing gum, or using tobacco."
- 3. **Hazards to Domestic Animals**: In order to be consistent with the directions for use and animal safety data, retain the reference to cats weighing 2.2 lbs. The statement should read: "Do not use on cats under 2.2 pounds" Remove the reference to 5 pound cats.

Directions for Use – For Use on Cats

4. Retain the reference to 2.2 lbs. cats because identification of the lower weight limit is necessary for animal safety. The statement should read: "Weighing 2.2 pounds to 5 pounds -..."

If you intend to sell products exclusively for either small or large cats, please inform EPA.
