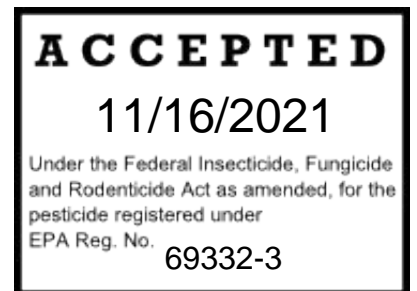

Apply one [0.047 fl oz (1.4 mL)] [tube] [vial] of {Brand Name} [solution] as a spot or stripe, starting high on the back of the cat's neck to in front of the shoulder blades. Do not double dose the cat.
