d. Replace "Cyper 1% Horse Spray with "ecotomethrin H2O Equine Spray" wherever this occurs on the label.

e. Under Directions for Use delete, "Avoid contact with eyes or mucous membranes. Harmful if swallowed. Avoid contamination of food.". These statements correctly appear under Precautionary Statements.

3. Please note that a notice of availability of EPA's registration eligibility document (RED) for product containing Cypermethrin was published in the FR on August 16, 2006 (Vol 71 No 158 page 47210-47212). Additional data and/or labeling changes may be required for products containing Cypermethrin.

4. Please submit two (2) copies of your final printed labeling before releasing the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions. A stamped copy of the label is enclosed for your records.

To protect horses and ponies from Horse Flies, House Flies, Stable Flies, Face Flies, Horn Flies, Deer Flies, Gnats, Mosquitoes (culex spp): Thoroughly brush the horse's coat prior to application to remove loose dirt and debris. For dirty horses, shampoo and rinse thoroughly. Wait until the coat is completely dry before applying this product. Cyper 1% Horse Spray's unique sweat resistant formula contains a special conditioner that binds to the hair shaft so it keeps working when the horse sweats.

[Sponge-On Application: Shake well before using. Apply Cyper 1% Horse Spray with the specially designed sponge applicator attached to the bottle.
