The Agency, in accordance with the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, has completed reviewing all the information submitted with your application to support the Registration Review of the above referenced product in connection with the Cypermethrin Interim Decision, and has concluded that your submission is acceptable. The label referred to above, submitted in connection with registration under FIFRA, as amended, is acceptable.

Should you wish to add/retain a reference to the company's website on your label, then please be aware that the website becomes labeling under the Federal Insecticide, Fungicide, and Rodenticide Act and is subject to review by the Agency. If the website is false or misleading, the product would be misbranded and unlawful to sell or distribute under FIFRA section 12(a)(1)(E). 40 CFR 156.10(a)(5) list examples of statements EPA may consider false or misleading. A stamped copy of your labeling is enclosed for your records. This labeling supersedes all previously accepted labeling and must be used at your next label printing. You must submit one copy of the final printed labeling before you release the product for

To protect horses and ponies from Horse Flies, House Flies, Stable Flies, Face Flies, Horn Flies, Deer Flies, Gnats, Mosquitoes (culex spp). Thoroughly brush the horse's coat prior to application to remove loose dirt and debris. For dirty horses, shampoo, and rinse thoroughly. Wait until the coat is completely dry before applying this product. [Product Name] [This products'] sweat resistant formula contains a special conditioner that binds to the hair shaft, so it keeps working when the horse sweats. Application of product on pets must only be done indoors.

Reapply every 14 days for fly control under normal conditions for initial applications. Reapply every 5 to 7 days for mosquito repellency. Also, reapply each time animal is washed or exposed to heavy rain.
