d. Revise the Statement of Practical Treatment to read:

IF SWALLOWED: Call a physician or Poison Control Center. Dri nk 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

IF IN EYES: Flush eyes with plenty of water.

Call a physician if irritation persists.

Shake well before using. After application any powder visible should be carefully brushed into cracks and crevies or removed. Do not use in wet or damp areas.

HOUSEHOLD APPLICATION; Apply liberally behind and under sink. stove, refrigerator, dishwasher, washer and dryer, Remove lower cabinet drawers in kitchen and bath and liberally scatter powder in cabinet wells. Apply into opening around pipes, drains, window sills under the Federal insecticide, and door lams. Check baseboards and apply powder into cracks and pcrevices.

STORAGE: Store only in original container, in a dry place inaccessible prod under EPA Reg. No. to children and pats.
