
1. Submit the required one year storage stability and corrosion characteristics study by January 31, 2013. If these studies are not submitted by the due date, your product can be subject to cancellation.
2. Add the EPA Reg. No. 69361-30, and the complete EPA Establishment Number to your label before shipment.
3. Under "Directions For Use", change "bermudagrass" to "winter dormant bermudagrass". Change the non-specific "bearing fruit and nut trees" to "Citrus Fruits Group 10, Pome Fruits Group 11, Stone Fruits Group 12, Tree Nuts Group 14". Remove "forage legumes" because there is no tolerance established for the Forage of Legume Vegetables Group 7.

Change "fruiting vegetables" to "Fruiting Vegetables (except Cucurbits) Group 8".  
And change "peas" to "peas (except field peas)" to reflect the established tolerance. Add  
"pistachio", because it has a separate tolerance, and is not included in the Tree Nuts Group 14.

Submit one copy of your corrected final printed labeling before you  
release the product for shipment. Release of product for ship constitutes  
acceptance of these changes to your draft submitted label. A stamped copy of  
labeling "Accepted with Comments" is enclosed for your records.
