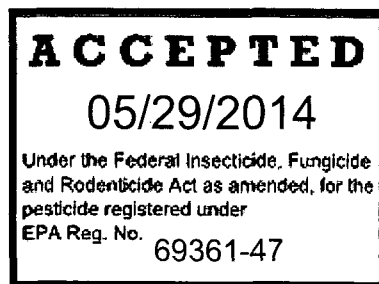

2. Domestic Indoor (household), Domestic Outdoor (lawns, perimeters, ornamentals), Commercial Industrial Institutional (indoor and outdoor), Food Handling Establishments (edible product areas), Terrestrial Non-Food (sod farms, golf courses, non-agricultural sites), various modes of transportation;
