CAUTION: May be harmful if swallowed or absorbed through skin. May cause eye irritation. Avoid contact with eyes. Wash thoroughly after handling.

Add a Hazards to Domestic Animals Statement which reads as follows:

Some animals may be sensitive to ingredients in this product. Following treatment, observe your pet for possible signs of sensitivity or adverse reactions to this product. If signs persist, or become more severe, consult a veterinarian immediately.

f. Revise the Statement of Practical Treatment to read as follows:

IF SWALLOWED: Contact a physician or poison control center. Induce vomiting by touching back of throat with finger. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person. IF IN EYES: Flush eyes with plenty of water. Get medical attention if irritation persists. IF ON SKIN: Wash thoroughly with soap and water. Get medical attention if irritation persists.

- g. Add the statement "To prevent harm to you and your pet, read entire label before use."
- h. Add the statement "Do not use on puppies or kittens under 6 weeks old. Consult your veterinarian before using this product on pregnant or lactating females, and old, sick or debilitated animals."
- i. Delete "Leaves a lustrous coat" and "The pet will have a clear, lustrous coat, free of fleas and ticks."
- Revise the phrase "with a product approved for domestic indoor or outdoor use" to read "with a product registered for use in these areas."
