PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

PHYSICAL AND CHEMICAL HAZARDS

DIRECTIONS FOR USE

FOR HOUSEHOLD USE ONLY: IMPORTANT: Use only as a surface spray. Hold can in an upright position to spray. **SHAKE WELL BEFORE EACH USE.** Direct spray away from face. Hold can two feet from surfaces. Spray at a rate of 1 foot per second unless directed otherwise. For long lasting residual (up to 12 weeks), leave spray residue undisturbed. Repeat applications as needed.

Flies, Mosquitoes Gnats Small flying moths Wasps, Paper Wasps Mud dauber wasps Hornets, Bees Yellowjackets	Spray directly on insects whenever possible. Also treat screens, walls, door and window frames, and other outdoor surfaces where insects are observed. To treat outdoor nests of paper and mud dauber wasps: Apply a wet spray after dark when all insects have returned to their nests.
Brown dog ticks Deer ticks Fleas	Remove and discard infested pet bedding. Thoroughly spray cracks, crevices and areas where pets normally rest. DO NOT spray pets directly. allow treated areas to completely dry before replacing new bedding or permitting use by animals. Treat outside premises, dogs and cats with registered tick or flea control products prior to re-entry.
Bed bugs	Spray directly on insects (pests) whenever possible. Thoroughly spray cracks, crevices, baseboards, underneath chairs, tables, beds and sofas, around points of entry and other places where these insects (pests) are observed. Furniture, especially sofas, mattresses and bed springs, should be lightly sprayed. NEVER treat infant furniture. Allow spray residues to completely dry before use.

Allow to dry before replacing contents. Do not allow food to directly contact treated surfaces. Repeat as needed.
