

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed, inhaled, or absorbed through skin. Prolonged or frequently repeated contact may cause allergic reactions in some individuals. Avoid contact with skin, eyes, or clothing. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse. Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food/feed is exposed or facility is in operation. Serving areas are areas where prepared foods/feed are served such as dining rooms but excluding areas where foods may be prepared or held. In the home all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Nonfood/nonfeed areas are areas such as garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

FIRST AID:

IF SWALLOWED: Immediately call a poison control center or doctor. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give any liquid to the person. Do not give anything by mouth to an unconscious person.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth, if possible.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes.

PHYSICAL OR CHEMICAL HAZARDS

Flammable. Contents under pressure. Keep away from heat, sparks and open flame. Leave doors open for 10 minutes after spraying in an enclosed space, including cabinets, closets and small rooms. Do not use at a rate of more than 1 can per 8' x 8' x 8' room. Do not spray near pilot lights or other open flames. Do not puncture or incinerate container. Exposure to temperatures above 130 degrees F may cause bursting.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store in a cool, dry area inaccessible to -or- out of reach of children and pets, and away from heat or open flame.

Disposal: Do not puncture or incinerate! If empty: Place in trash or offer for recycling if available. If partly filled: Call your local solid waste agency or 1-800-CLEAN up for disposal instructions.

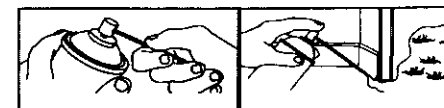

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

INSERT THE EXTENSION TUBE INTO THE SPRAY ACTUATOR.



FOR USE IN HOUSEHOLDS, NON-FOOD/FEEED AREAS OF WAREHOUSES, OFFICE BUILDINGS, THEATERS, GARAGES, HOTELS, MOTELS AND KENNELS. NOT FOR USE IN USDA MEAT AND POULTRY PLANTS.

TO KILL COCKROACHES, ANTS, CRICKETS, WATERBUGS, PALMETTO BUGS, SCORPIONS AND PILLBUGS: TO KILL ROACHES AND ANTS QUICKLY -OR- FAST [ON CONTACT] -OR- FOR QUICK KILL: Spray directly on [visible] roaches and ants.

TO CREATE A BARRIER TO KEEP ROACHES [AND/OR ANTS] OUT! -OR- AWAY FOR [UP TO] 3 -or- 4 -or- 5 -or- 6 months.

TO CREATE A BARRIER AGAINST ROACHES [AND/OR ANTS] FOR [UP TO] 3 -or- 4 -or- 5 -or- 6 months.

TO PREVENT ROACHES [AND/OR ANTS] FROM COMING BACK AND TO PROTECT AGAINST FUTURE ROACH PROBLEMS.

Spray on floors, along baseboards in the kitchens and baths, [using the extension tube to spray into cracks and crevices]. Spray at a rate of 5 seconds per linear foot. Special attention should be paid to areas around refrigerators and entry points such as doors, windows, vents, pipes, etc.

TO KILL SOWBUGS, CENTIPEDES, SILVERFISH, FIREBRATS AND SPIDERS: Contact as many insects as possible with the spray. Also thoroughly spray all parts of the room suspected of harboring these pests. Special attention should be paid to cracks, crevices, hidden surfaces under sinks and behind refrigerators.

TO KILL CARPET BEETLES: Spray directly on beetles, floors, baseboards, shelves, and carpet. Allow carpet to dry thoroughly before use. Repeat treatment as necessary.

TO KILL BEDBUGS: Spray mattresses, particularly around tufts and seams. Take beds apart and spray into all joints. Treat baseboards, moldings, and floors. Allow all treated articles to dry thoroughly before use. Repeat treatment as necessary.

TO CONTROL CLOTHES MOTHS: Remove any infested articles from storage, brush thoroughly, and air for several hours in sunlight, if possible. Apply spray liberally to empty chests, closets, bureaus, and other storages, directing the spray into cracks, joints, and crevices. After airing, infested articles may be treated lightly, keeping nozzle at least three feet from fabric to avoid staining.

TO KILL FLEAS AND BROWN DOG TICKS: Remove and destroy pet's old bedding. Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks and focal areas of floors. Repeat as necessary.

DO NOT SPRAY ON ANIMALS. Old bedding should be removed and replaced with clean, fresh bedding after treatment. Also treat dogs and cats with a registered flea and tick control product before allowing them to enter treated area.
