DIRECTIONS FOR USE

It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Read entire label and use strictly in accordance with precautionary statements and directions. For formulation into end-use products intended for disinfectants, sanitizers, fungicides, bactericides and algaecides for pools, spas, hot tubs, industrial recirculating water cooling towers, air washers and evaporative condensers, sewage treatment, food contact surfaces, laundry and egg sanitizing. Formulators using this product are responsible for obtaining EPA registration of their formulated products.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE:

Store in a dry, cool and well-ventilated area. Avoid moisture getting into container. Keep off wet floors. In case of spillage, wash with large amounts of water. After each use, keep container tightly closed. Oxidizing material. Keep away from flames, sparks and all sources of heat. Avoid contact with organic material.

In case of contamination or decomposition do not reseal container. If possible, isolate container in open well-ventilated area. Flood with large volumes of water. Dispose of contaminated material in an approved landfill area.

When handling or dealing with spills, use impact-resistant goggles with side-shields, or face shield; body-covering clothes, including impervious rubber or plastic gloves and boots; use a dust respirator if dusting occurs. Sweep up dry spills and dispose of as described for pesticide disposal. If drum contents

are contaminated or decomposing, do not reseal container; isolate unsealed drum in the open or in a well-ventilated area; flood with large volumes of water if necessary.

PESTICIDE DISPOSAL:

{For rigid nonrefillable container (pail or drum) with/without liner or bag less than 50 lbs} **CONTAINER HANDLING:** Nonrefillable container. Do not re-use or refill this container. {Instructions for liner or bag management, removal and disposal}

[Completely empty liner or bag by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. When completely empty, offer for recycling, if available or dispose of liner or bag in a sanitary landfill or by incineration or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.]

{Instructions for management, cleaning and disposal of rigid container}

Completely empty rigid container by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full of water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times.

Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.

{For rigid nonrefillable container (pail or drum) with/without liner greater than 50 lbs} **CONTAINER HANDLING:** Nonrefillable container. Do not re-use or refill this container. {Instructions for liner management, removal and disposal}

[Completely empty liner or bag by shaking and tapping sides and bottom to loosen clinging particles. Empty residue into application equipment. When completely empty, offer for recycling, if available or dispose of liner or bag in a sanitary landfill or by incineration or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.]

Triple rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank. Fill the container ¼ full of water. Replace and tighten closure. Tip container on its side and roll it back and forth, ensuring at least one complete revolution, for 30 seconds. Stand the container on its end and tip it back and forth several times. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times.

Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
