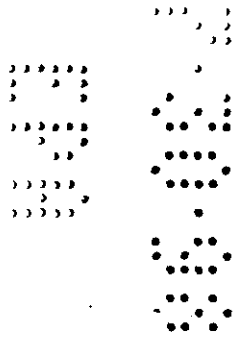

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

DANGER

CORROSIVE. Harmful. If swallowed, causes eye and skin irritation. Do not breathe vapors. Do not get in eyes, on skin, or on clothing. Wear clean and dry safety goggles and rubber gloves when handling material.

ENVIRONMENTAL HAZARDS

This product is toxic to fish and aquatic organisms. Do not contaminate water by cleaning of equipment or disposal of waste. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollution Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.

PHYSICAL AND CHEMICAL HAZARDS

This product is a strong oxidizer and contact with organic matter may cause fire. Contact with water liberates irritating chlorine-containing gases. At temperatures above 325 degrees F decomposes with liberation of toxic gases. In case of fire or thermal decomposition, isolate container and flood with large amounts of water.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

1. Adjust and maintain pool water pH in a range of 7.2-7.8 as indicated by available test kit. Use suitable agents to lower or increase pH. Follow instructions for use on the label of these products.
2. For maximum effectiveness it is recommended that the pool be first stabilized with 40-60 ppm Cyanuric Acid to reduce chlorine loss in sunlit pools. Follow instructions on the label of the product used. This product introduces chlorine and additional Cyanuric Acid into the pool to assure the stabilizing effect.
3. Place one (1) skimmer stick per 10,000 gallons of pool water every week into suitable feeder or directly into a stick skimmer basket.
4. A free available chlorine level of 1.0 - 1.5 ppm should be maintained. Check pool frequently with a test kit and maintain residual chlorine level between 1.0 and 1.5 ppm and pH of 7.2 - 7.8.

REENTRY: Reentry into treated swimming pools is prohibited above levels of 3 ppm of chlorine due to risk of bodily injury.

Circular	Diameter x diameter x average depth x 5.9

STATEMENT OF PRACTICAL TREATMENT (FIRST AID)

IN CASE OF CONTACT WITH SKIN: Remove material and flush with large quantity of water. Remove contaminated clothing. Call physician if irritation continues.

IN CASE OF CONTACT WITH EYES: Flush for 15 minutes with large quantity of water. Call a physician.

IF SWALLOWED: Drink a large quantity of water. Call a physician.

IF INHALED: Remove person to fresh air. Call a physician.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

Store in a dry, cool and well-ventilated area. Avoid moisture getting into container. Keep off wet floors. In case of spillage, wash with large amounts of water. After each use, keep container tightly closed. Oxidizing material. Keep away from flames, sparks and all sources of heat. Avoid contact with organic material.

PESTICIDE DISPOSAL: Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste representative at the nearest EPA Regional Office for guidance.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or incineration, or, if allowed by state and local authorities, by burning. If burned, stay out of smoke.
