

#### **USE RESTRICTIONS**

CIVITAS™ is a broad spectrum, fungicide and insecticide registered for use on turf and the landscape ornamentals listed on this label. CIVITAS™ may be used to control powdery mildew, adelqids and webworms on landscape ornamentals.

CIVITAS™ may be applied as part of an alternating spray program or in tank mixes with other registered, turf and ornamental protection products. Read all label directions for proper use of other turf and ornamental protection products.

CIVITAS™ may be used as a preventative treatment for the control of many diseases on turf.

For turf applications, CIVITAS™ must only be used in conjunction with Petro-Canada's CIVITAS™ HARMONIZER.

Do not use CIVITAS™ HARMONIZER for ornamental applications.

CIVITAS™ may be applied with spray equipment commonly used for ground applications. Ensure sufficient agitation is provided either through the use of mechanical mixing or thorough circulation.

#### SPRAY DRIFT MANAGEMENT

A variety of factors including weather conditions (e.g., wind direction, wind speed, temperature, and relative humidity) and method of application (e.g. ground or airblast) can influence pesticide drift. The applicator and grower must evaluate all factors and make appropriate adjustments when applying this product.

#### Wind Speed

Do not apply at wind speeds greater than 15 mph at the application site.

#### **Temperature Inversions**

If applying at wind speeds less than 3 mph, the applicator must determine if (a) conditions of temperature inversion exist, or (b) stable atmospheric conditions exist at or below nozzle height. Do not make applications into areas of temperature inversions or stable atmospheric conditions.

#### Release Height

Apply using a nozzle height of no more than 4 feet above the ground or crop canopy.

#### **Droplet Size**

Apply as a medium or coarser spray (ASAE standard 572), and the minimum volume mean diameter (VMD) for spinning atomizer nozzles.

For airblast applications, turn off outward-pointing nozzles at row ends and when spraying outer row. To minimize spray loss over the top in orchard applications, spray must be directed into the canopy.

### **INTEGRATED PEST MANAGEMENT (IPM)**

Pests are not known to develop resistance to CIVITAS<sup>TM</sup>. This product can be used in resistance management strategies or in integrated pest management (IPM) programs. #### **DIRECTIONS**

Use only in equipment with sufficient agitation to keep spray thoroughly mixed. Provide sufficient agitation during mixing and application to maintain a uniform emulsion. Be sure tank is clean.

#### DO NOT USE THIS MATERIAL IF IT DOES NOT EMULSIFY.

**Note:** Use efficient equipment of the proper type. Avoid spraying during or immediately prior to hot or freezing weather, rain or other unsuitable conditions; avoid over spraying or double spraying. #### For Ornamental Applications:
