

- 2) Shut off exhaust systems to reduce air turbulence during blending/mixing addition of R-ST™ 10.
- 3) Add R-ST™ 10 after the addition of liquid ingredients and blend until uniform.

STORAGE AND DISPOSAL: Protect from heat. Do not contaminate water, food, or feed by storage or disposal. Wastes resulting from this product may be disposed of on site or at an approved waste disposal facility. Triple rinse (or equivalent).
