
The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided you make the following changes before you release the product for shipment bearing the amended labeling:

1. The EPA Registration and Establishment Numbers should be moved to the top of the label, under the ingredient statement.
2. Revise the Precautionary Statements by adding the following respirator information:  
"....breathe dust. When mixing concentrates or baits, use a dust/mist filtering respirator (MSHA NIOSH approval number prefix TC-21C), or a NIOSH approved respirator with any R, P, HE filter. Wear protective clothing and waterproof gloves. Wash arms...."
3. Revise the Environmental Hazards statement as follows: "This product is toxic to fish and wildlife. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously

notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.”

### DANGER

<b>If in eyes:</b>	<ul style="list-style-type: none"> <li>• Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.</li> <li>• Call a poison control center or doctor for treatment advise.</li> </ul>

### NOTE TO PHYSICIANS

If ingested, administer Vitamin K, intramuscularly or orally, as indicated in bishydroxycoumarin overdoses. Repeat as necessary, based on monitoring of prothrombin times. Severe cases may require administering Vitamin K, intravenously and giving blood transfusions.

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

**Storage:** Store in a cool, dry area inaccessible to children, pets and domestic animals.

In case of minor spills, follow all precautions indicated above and cleanup immediately. Sweep up and dispose of wastes and broken or empty containers in a landfill approved for pesticide use.

**Pesticide Disposal:** Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency or the Hazardous waste representative at the nearest EPA Regional office for guidance.
