#### Refrigerators / (and) (Freezers):

Tear open the foil pouch immediately prior to use and remove the (5) (10) (20) (50) gram (sachet) (deodorizing pouch). Hang or place the (sachet) (deodorizing pouch) anywhere within the refrigerator. Each sachet will treat up to 2 months.

NOTE: This product can only be used in commercial (non-residential) refrigerators that do not store food.

### Shoes:

[Step 1:]Tear open the foil pouch immediately prior to use and remove the (5 grams sachet) (shoe deodorizer pouch).
