General Information:

BABOLNA BIO Flea Killer Spray contains methoprene, an Insect Growth Regulator (IGR), and insecticide combination for indoor control of fleas and ticks. The spray gives protection against both adults and flea larvae. Methoprene works specifically on pre-adult fleas, preventing them from maturing into biting adults. Pyrethrins and permethrin, which efficacy is enhanced by a special synergist, kill adult fleas and ticks. BABOLNA BIO Flea Killer Spray is especially developed for surface treatment. **Do not spray BABOLNA BIO Flea Killer Spray.**

Application:

Cover or remove food, dishes, and food-containers. All food processing surfaces should be covered during treatment or thoroughly cleaned before using. Cover (and unplug) aquariums and remove birds and other pets before treatment. Vacuum thoroughly before spraying. A test application should be made to upholstery or drapery fabrics in an inconspicuous place before use.

Shake well before using. The container should be held about 30 cm (one foot) from the surface to be treated. Spray uniformly the entire floor and the walls up to 1 meter (approximately 3 feet) height. Apply uniformly with sweeping motion. Give special attention to cracks and crevices. Also treat carpets, rugs, tiles, furniture, under furniture cushions, pet bedding and places where pets like to rest. Only complete coverage will provide complete flea control, but avoid thoroughly wetting the area that needs treating. Avoid contact with treated surfaces until dry.

For best results, use BABOLNA BIO Flea Killer Spray prior to the flea season and repeat treatment after half a year. In case the spray is washed off, repeat treatment.

Flea control on pets is important in prevention of introduction of adult fleas indoors. When using this product, and fleas are problems on pets, the pets should be treated with an effective registered flea control product to prevent the introduction of adult fleas indoors. **Do not spray BABOLNA BIO Flea Killer Spray directly onto pets.**

Storage and Disposal

Do not contaminate water, food, or feed by storage or disposal.

Pesticide Storage: Store in a cool, dry place, away from heat, sparks and open flame. Keep container closed and out of reach by children and animals.

Pesticide Disposal and Container Handling: Nonrefillable container. Do not reuse or refill this container.

If empty: Offer for recycling if available. If the recycling option is not available, discard container in the trash.

If partly filled: Call your local solid waste agency for disposal instructions. Never place any unused product down any indoor or outdoor drain.
