The amended label and Confidential Statement of Formula (CSF) referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, are acceptable. After 18 months, you may only distribute or sell this product if it bears this new revised labeling or subsequently approved labeling. Turn the container over onto its other end and tip it back and forth several times. Empty the rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Repeat this procedure two more times. Then offer for recycling or reconditioning, if appropriate, or puncture container and dispose of in a sanitary landfill or by other procedures approved by state and local authorities.
