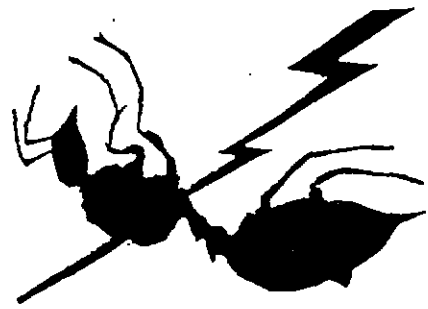

4. USE ONE GALLON OF MIXTURE PER ANT MOUND.
5. CONFINE MIXTURE TO THE AREA OF THE ANT MOUND. IN APPLICATIONS ON LAWNS, PRODUCT MAY CAUSE BROWNING OF, OR KILL, GRASS AROUND EDGES OF ANT MOUNDS.
6. FOR BEST RESULTS, USE DURING COOLER PARTS OF THE DAY, EARLY TO MID-MORNING, AND NOT DURING PROLONGED HOT AND DRY CONDITIONS.
