


c. The "Environmental Hazards" Statement should state:

3. Submit two copies of the revised final printed label for the record.

DIRECTIONS FOR USE

It is a violation of federal law to use the product in a manner inconsistent with its labeling.

Chlor-Free™ is designed for use in all swimming pools, spas and fountains.

Chlor-Free™ is a compound of chemicals required for water balance, purification, pH adjustment, algacide and stabilizer.

When used according to these directions, **Chlor-Free™** will effectively control algae in a pool/spa/fountain.

Perform a weekly pH test. If the pH is 7.6 or higher add **Chlor-Free™** directly into the pool while pump is running. Based on the pH test, the required dose of **Chlor-Free™** is determined by the following TABLE:

The correct range is 7.2 - 7.6 for swimmer comfort.

Retest 3 hours later. Adjust with more compound if required.

It is safe to swim after dosing with compound.

Mix only in water. Do not mix with other chemicals. Wash hands after use.

Chlor-Free™ coagulates most suspended matter, dust, dirt or milky water and drops it to the floor of the pool. The pool cleaner will pick it up and deposit it into the filter.

STORAGE AND DISPOSAL

STORAGE:

Keep product dry in tightly closed container when not in use. Store in cool, dry, well ventilated area away from heat or open flame. Store in Original Container and in Locked Area. Do not contaminate water, food or feed by storage or disposal. In case of decomposition isolate container and flood with large amounts of water to dissolve all material before discarding. Do NOT mix with other chemicals.

DISPOSAL:
