Changes included in this notification are as follows:

- Pages 1, 2, 9 of the Master label Add new EPA Est. No. 089546-NV-001.
- Pages 2 and 9 of the Master label Add the words 'first aid".
- Pages 4 and 10 of the Master label Add the statement '1 scoop = 3 tablespoons'.
- Pages 5 and 11 of the Master label <u>Application Instructions</u>: Change the word 'Add' to 'Broadcast'
- Pages 5 and 11 of the Master label <u>General Treatment Notes</u>: Delete the phrases in early spring and.
- Page 5 of the Master label General Treatment Notes: Change the following statement from: 'For flare-ups and spot treatments, use GreenClean Granular according to later directions. The statement now reads: 'For flare-ups and spot treatments use GreenClean Granular for GreenClean®FX Liquid Algaecide according to label directions. #### FOR STOCK TANKS AND LIVESTOCK WATER:
