On the basis of information furnished by the registrant, the above named pesticide is hereby registered under the Federal Insecticide, Fungicide and Rodenticide Act.

In order to protect health and the environment, the Administrator, on his motion, may at any time suspend or cancel the registration of a pesticide in accordance with the Act. This product is conditionally registered in accordance with FIFRA sec. 3(c)(7)(C) provided that you do the following:

1. Change the label by revising the EPA Registration Number to read, "EPA Reg. No. 70464-4".
2. Submit five copies of the revised final printed label for the record.
3. Provide analyses of 5 batches at production and include data relevant to:
  - (a) detection and regulatory limits of beauvericin and any other fungal metabolites of toxicological concern associated with *Beauveria bassiana* strain 447.
  - (b) detection, identification, enumeration and rejection limits of potential human pathogens (bacterial and fungal) using the selective media proposed in the analysis of production batches. All batches containing human pathogens above regulatory levels must be destroyed.

The production data will be a condition of registration and must be submitted within one year of the date of registration. The monitoring period may be longer depending on the evaluation of the data submission.

The following data are required only if you wish to register the pests discussed in condition 4 below. These target pests were included in your original registration proposal and you have agreed not to include them on the registered label at this time, because the submitted data did not support their proposed registration.

4. Submit data demonstrating the efficacy of *Beauveria bassiana* strain 447 as a bait for control of ant colonies and cockroach, should you wish to register these target pests on the label.

Should you decide not to register the target pests discussed in condition 4 above, you must inform the Agency in writing of your decision and request that these conditions be removed from this conditional registration. Otherwise data must be submitted to satisfy the conditions described below within 2 years of the conditional registration.

Any requests for time extensions to provide the data listed above must be submitted in writing prior to the appropriate deadline. If EPA determines, at any time, that additional data are required to maintain in effect an existing conditional registration, the Agency will require submission of such data under Section 3(c)(2)(B) of the Federal Insecticide Fungicide and Rodenticide Act (FIFRA), as amended. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

A stamped copy of the approved label in connection with this conditional registration is enclosed for your records. Baits Motel Ant Bait Stations are intended to kill common household ants (including: Carpenter, Ghost, Pharaoh, Crazy, Pavement and Argentine), and Fire ants.

**How The Bait Works:**

Foraging ants are attracted to the Baits Motel Ant Bait Station. Ants visiting the Bait Station become coated with fungal spores that germinate on their bodies. Once these and fellow ants come in contact with the fungal spores, they become infected and die within a few days.

**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

Do not place baits where food is being prepared or on utensils that are used for food preparation. Do not place bait stations in areas accessible to children and pets. Do not remove bait material from the bait station.

Remove individual bait stations from the outer packages only when you are ready to use them. Immediately prior to use, puncture small entry holes where indicated on the bait station. Place individual bait containers near ant trails, where ants may enter your home, or near where ants are numerous – such as under sinks, cupboards, refrigerators, stoves, drawers, shelves, toilets, hot water systems and washing machines.
