b. Modify your description statement on the front panel to reflect the same description statement for the technical label (e.g. for indoor, non-food uses as a preservative in synthetic polymer emulsions, latex paint, aqueous slurries, photographic emulsions, metal working fluids, oil drilling fluids).

c. Modify the "Precautionary Statement" to read:

Hazards to Humans and Domestic Animals

Corrosive. Causes irreversible eye damage or skin burns. Do not get in eyes, on skin or on clothing. Wear goggles or face shield. Wear protective clothing and rubber gloves. Wash hands before eating, drinking, chewing gums, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse.

d. In the statement "IF ON SKIN", change the word "sap" to "soap".

e. In the "NOTE TO PHYSICIAN" section, delete the sentence "Measures against circulatory shock, respiratory depression and convulsion may be needed".

2. This product is being registered on the condition that a 90-day dermal study is submitted to the Agency within one (1) year of the date shown on the "Notice of Registration" form for the technical product (XBINIX 88). This conditional registration will expire automatically on June 1, 2000. If you fail to satisfy the conditions imposed in this notice of registration, EPA may issue a a Notice to Cancel under Section 6(e) of FIFRA.

3. Submit two copies of the revised final printed label for the record.


