2. Change the Descriptor statement under the product name from "This product may be used only for formulating Indoor, Non-food use products such Preservatives in Synthetic Polymer Emulsions, Latex Paints, Aqueous Slurries, Photographic Emulsions, Methal Working Fluids. For Use (In Can) To pevent Spoilage of Pesticides, Soaps and Detergents. Also For Use In Oil Drilling Fluids and Construction Materials such as Adhesives" to read "This product may be used only for formulating Indoor, Non-food Use Products such Preservatives in Synthetic Polymer Emulsions, Latex Paints, Aqueous Slurries, Photographic Emulsions, Methal Working Fluids. For Use (In Can) To prevent Spoilage of Pesticides, Soaps and Detergents. Also For Use In Oil Drilling Fluids and For Use In Adhesives Intended For Use In Construction".

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.


