The Agency, in accordance with the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, has completed reviewing all of the information submitted with your application to support the reregistration of the referenced product in connection with the CYPERMETHRIN RED, and have concluded that your submission is acceptable with the following label revision provision(s):

General Comment(s):

Delete "but not limited to" wherever it appears on the label.

Change "Domestic Indoor/Outdoor (non-commercial homeowner) Uses: "to "Homeowner Indoor/Outdoor Uses".

Change "Domestic Outdoor- Wood or Wood Structure Protection Treatments" to "Domestic Outdoor- Wood or Wood Structure Non Termite Treatment".

Change "General Outdoor Insect Control (Non-food Uses)" to "Outdoor Surfaces at Residential, Animal Premises, Commercial and Industrial Sites.".

First Aid section comment(s):

Add IF INHALED:

- Move person to fresh air.
- If person is not breathing, call 911 or an ambulance, and then give artificial respiration, preferable mouth- to- mouth if possible.
- Call a poison control center or doctor for further treatment advice.

Change "Call a poison control center or doctor immediately for treatment advice." to "Immediately call a poison control center or doctor for treatment advice."

Environmental Hazards section comment(s):

After "May be fatal if swallowed." add "May be fatal if inhaled. Do not breathe vapor.".

Hazards to Humans and Domestic Animals section comment(s):

Replace this section with Warning: May be fatal if swallowed. Harmful if absorbed through skin. Harmful if inhaled. Causes moderate eye irritation. Avoid breathing vapor or spray mist. Avoid contact with eyes, skin, or on

clothing. Prolonged or frequently repeated skin contact may cause allergic reactions in some individuals. User should wash hands before eating, drinking, chewing gum, using tobacco, or using the toilet. Remove contaminated clothing and wash clothing before reuse.

Directions for Use Comment(s):

Change "This product may not be formulated ibto ...or rights of way." to "This product may not be formulated into ...or rights of way.

Physical and Chemical Hazards section comment(s):

Change "Do not use or store near heat or open flame." to "Combustible: Do not use or store near heat or open flame."

Should you wish to add/retain a reference to the company's website on your label, please be aware that the website becomes labeling under FIFRA and is subject to review by the Agency. <u>Terrestrial Outdoor, Non-food Uses</u>: Ornamentals including non-bearing fruit and nut trees grown for ornamental purpose, evergreens, ornamental trees, shrubs, vines, ground covers, lawn and turfgrass grown around industrial and commercial buildings, private homes, duplexes, townhouses, condominiums, house trailers, apartment complexes, carports, garages, sport fields and complexes, tennis courts, fence lines, storage sheds, barns, and their structures (fences, posts, slabs, crawlspaces, foundations, porches, window frames, eaves, patios, garages) and refuse dumps.
