Label Amendment incorporating Napropamide RED label revisions

Submission dated March 11, 2008

Dear Ms. Clemmer:

The labeling referred to above, submitted in connection with reregistration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is acceptable, provided you make the following changes before you release the product for shipment.

- 1) Add an appropriate EPA Establishment Number to the label
- 2) On page 3, revise the first bullet to "DEVRINOL 10-G herbicide may be used on mineral soils only. Do not use on soils with over 10% organic matter."
- 3) On page 5, revise "Recommendations" to "Crop Use Directions" in the statement "NOTE: See Recommendations Section for weeds controlled in Cranberries."
- 4) On page 5, revise the statement "For control of all weeds listed, apply 40 lbs of DEVRINOL 10-G per acre to a weed free soil surface" to "Apply DEVRINOL 10-G to a weed free soil surface at rates specified in the following crop use directions sections.
- 5) On page 5, remove the crop "Walnuts" from the section TREES AND VINES, as this use in now cancelled per the Napropamide RED.
- 6) On page 6, add "per acre" after "4 lbs ai (40 lbs product)" in the section TREES AND VINES
- 7) On page 6, add "per acre" after "9 lbs ai (90 lbs product)" in the section CRANBERRIES.

Submit one (1) copy of final printed labeling incorporating the above changes before you release the product for shipment. Amended labeling will supercede all previously accepted ones. - Treating ground heavily covered with leaves or trash may adversely affect weed control.

Do not apply to frozen ground.

 To avoid injury to crops not specified on this label, do not plant until 12 months after the last DEVRINOL 10-G herbicide application. A deep disc plow or moldboard plow operations must be carried out before planting.

AGRICULTURAL USE REQUIREMENTS

Use this product only in accordance with its labeling and with the Worker Protection Standard, 40 CFR part 170. This Standard contains requirements for the protection of agricultural workers on farms, forests, nurseries, and greenhouses, and handlers of agricultural pesticides. It contains requirements for training, decontamination, notification, and emergency assistance. It also contains specific instructions and exceptions pertaining to the statements on this label about personal protective equipment (PPE) and restricted-entry interval. DEVRINOL 10-G is a selective surface-applied herbicide for use in certain, nuts, small fruits, strawberries and direct seeded tobacco plantbeds. DEVRINOL 10-G does not control established weeds. All weed growth and crop stubble in the fields must be thoroughly worked into the soil prior to planting. Application equipment should be carefully calibrated before use and checked frequently during application to be sure equipment is free from clogging and is delivering a uniform pattern. Apply the specified rate of DEVRINOL 10-G by ground or air equipment.

NOTE: All rates are given on a broadcast basis, per acre. Reduce rates proportionately for band or strip treatment.

A surface application of 40 lbs. DEVRINOL 10-G will control the following weeds:

NOTE: DEVRINOL 10-G does not control established weeds.

CROP USE DIRECTIONS

For control of all weeds listed, apply 40 pounds of DEVRINOL 10-G per acre to a weed free soil surface. Apply in the fall through early spring prior to weed emergence. For best results, the treatment must reach the zone of weed seed germination. If rainfall does not occur, the treatment must be shallowly incorporated or irrigated-in (sprinkler or flood) following application with sufficient water to wet the soil to a depth of 2 to 4 inches. In the Western and Pacific Northwest Regions treatments made in fall through early spring must be incorporated or irrigated-in if no rainfall occurs within two weeks of application. For treatments made other than in fall through early spring in these Regions, and for all treatments applied in the Northern, Southwestern and Southeastern Regions regardless of season, the treatment must be incorporated or irrigated-in within 24 hours if no rainfall occurs.

Avoid contact with fruit or foliage. Do not apply when fruit or nuts are on the ground during the harvest period. Do not graze treated areas.

Application may be made immediately after planting, except where treatment is restricted to established crops only. For these uses, apply to stands that have been established in the field for at least one year.

TREES AND VINES:

Filberts, Grapes, Pecans, and Walnuts. Apply 40 pounds DEVRINOL 10-G per acre to a weed

free soil surface. Maximum application rate per crop cycle: 4 lbs ai (40 lbs product). Apply a maximum of once per year.

STRAWBERRIES:

Apply 40 pounds DEVRINOL 10-G per acre to a weed free soil surface. Delay application until the desired number of daughter plants have become established. Do not apply from bloom through harvest.

BUSH FRUIT:

Blueberries and Caneberries (Blackberries, Raspberries, Boysenberries, Loganberries). Apply 40 pounds DEVRINOL 10-G per acre to a weed free soil surface.

CRANBERRIES:

CAUTION: Do not apply in the springtime to cranberry beds that do not have sprinkler systems for frost control.

Maximum application rate per crop cycle: 9 lbs ai (90 lbs product). Apply a maximum of once per year.

Northeast (Connecticut, Delaware, Massachusetts, Maryland, Maine, New Hampshire, New Jersey, New York, Pennsylvania, Rhode Island, Vermont, West Virginia)

Established beds (over one year old)

For control of nutsedge (*Cyperus dentatus*) and rice cutgrass (*Leersia oryzoides*) and purplestem beggarticks (*Bidens connata*), apply DEVRINOL 10-G at the rates indicated below to a weed free soil surface before spring growth begins or in the fall after harvest. Do not apply when beds are under winter flood.

In Peat Beds: Apply 60-90 pounds DEVRINOL 10-G per acre.

In Beds with Sandy Soils: Apply 40-60 pounds DEVRINOL 10-G per acre.

New Plantings

Apply 30 pounds DEVRINOL 10-G per acre to a weed free soil surface after planting.

North Central (Michigan, Minnesota, North Dakota, South Dakota, Wisconsin)

Established beds (over one year old)

For control of purplestem beggarticks (*Bidens connata*) and rice cutgrass (*Leersia oryzoides*), apply DEVRINOL 10-G at the rates indicated below to a weed free soil surface before spring growth begins or in the fall after harvest. Avoid applying when beds may be reflowed for spring frost protection or when soils are water soaked. Do not apply when beds are under winter flood. **In Peat Beds:** Apply 60-90 pounds DEVRINOL 10-G per acre.

In Beds with Sandy Soils: Apply 40-60 pounds DEVRINOL 10-G per acre.

New Plantings

Apply 30 pounds DEVRINOL 10-G per acre to a weed free soil surface after planting.

West (Idaho, Montana, Oregon, Washington)

Established beds (over one year old)

For control of clover (*Trifolium fimbriatum*), aster (*Aster douglasii*), silverweed cinquefoil* (silverleaf) (*Potentilla anserina*), red sorrel (sheep sorrel) (*Rumex acetosella*) and birdsfoot trefoil (*Lotus comiculatus*), apply DEVRINOL 10-G at the rates indicated below to a weed free soil surface before spring growth begins in mid-February or before the end of March. Do not apply after buds start to swell.

In Beds with Heavy Muck Soil: Apply 90 pounds of DEVRINOL 10-G per acre.

In Peat Beds: Apply 60 to 90 pounds DEVRINOL 10-G per acre.

In Beds with Sandy Soils: Apply 40-90 pounds DEVRINOL 10-G per acre.

New Plantings

Apply 30 pounds DEVRINOL 10-G per acre to a weed free soil surface after planting.

*Suppression only

MINT:

Established mint (Pacific Northwest only). Apply 40 pounds DEVRINOL 10-G per acre to a weed free soil surface.

TOBACCO:

Direct-seeded Plantbeds (Indiana, Kentucky, Maryland, Massachusetts, Ohio, Pennsylvania, Tennessee, Virginia and West Virginia). Apply 13.6 pounds DEVRINOL 10-G per broadcast acre or 6.0 oz. DEVRINOL 10-G per 1,200 sq. ft.

- For control of white clover (*Trifolium repens*), apply to a weed-free soil surface.
- Lightly incorporate or sprinkler irrigate within 24 hours using sufficient water to wet the soil to a 2 to 4 inch depth.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE: Keep container closed when not in use. Store in a cool dry place. Do not store near seeds, fertilizer or foodstuffs.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.
