
The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is acceptable, provided you make the following changes before you release the product for shipment.

- 1) Add an appropriate EPA Establishment number to the label
- 2) Change the signal word from WARNING to CAUTION in the PRECAUTIONARY STATEMENTS section. Remove "Wash hands thoroughly with soap and water after handling and before eating, drinking, or using tobacco. Remove contaminated clothing and wash before reuse" from the PRECAUTIONARY STATEMENTS section.
- 3) In the STORAGE AND DISPOSAL section, change the statement "Do not contaminate water, food or feed by storage, disposal" to "Do not contaminate water, food, or feed by storage or disposal."
- 4) Add "To the extent allowed by law" before the statement "UPI expressly disclaims any implied warranties of merchantability and fitness for a particular purpose and, except as set forth in the above paragraph, any other express or implied warranties" in the section CONDITIONS OF SALE AND LIMITATION OF WARRANTY AND LIABILITY.

Submit one (1) copy of final printed labeling incorporating the above changes before you release the product for shipment. Amended labeling will supercede all previously accepted ones. A stamped copy of labeling is enclosed for your records.

Terrestrial food and feed crop uses: Alfalfa, mixed stands of alfalfa and forage grasses, asparagus, barley, carrots, corn, fallow, garbanzo beans (chickpeas), forage grasses, grasses grown for seed, lentils, peas, potatoes, sainfoin, soybeans, sugarcane, timothy, tomatoes, and wheat.

Terrestrial non-food, non-domestic uses: Established Bermudagrass turf, ornamental lawns and turf (not residential), nonagricultural uncultivated areas/soils, recreational areas.

Uses for experimental purposes that are in compliance with USEPA requirements.

This product may be used to formulate products for specific use(s) not listed on the label if the formulator, user group, or grower has complied with U.S. EPA submission requirements regarding support of such use(s).

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, disposal.

PESTICIDE STORAGE: Store in cool, dry place and in such a manner as to prevent cross contamination with other pesticides, fertilizers, food and feed. Store in original container and out of reach of children, preferably in a locked storage area.
