Devrinol 2-EC is a selective, surface-applied herbicide for use in strawberries. It is also recommended for weed control in tomatoes, peppers, and tobacco, applied and incorporated prior to planting.

Devrinol 2-EC controls weeds before they emerge. It does not control established weeds. All weed growth and crop stubble in fields intended for tomatoes and peppers or tobacco must be thoroughly worked into the soil prior to planting.

Spray equipment should be carefully calibrated before use and checked frequently during application to be sure nozzles are free from clogging and are delivering a uniform spray pattern. Apply the recommended rate of Devrinol 2-EC in 20 to 100 gallons of water per acre.

NOTE: All rates given below are broadcast rates. Reduce rates proportionately for band or strip treatment.

For control of all weeds listed above, apply 2 gallons (8 quarts) Devrinol 2-EC per broadcast acre to the soil surface. Apply in the fall through early spring, prior to weed emergence. Do not apply Devrinol 2-EC to frozen ground. Do not apply Devrinol 2-EC from bloom through harvest. For best results, the treatment must reach the zone of weed seed germination. Treatments made other than in November through February must be irrigated-in within 24 hours (sprinkler or flood) with sufficient water to wet the soil to a depth of at least 2 to 4 inches. Irrigation or shallow incorporation is recommended for treatments made from November through February if no rainfall occurs within one week of application.

Options for Strawberries Grown on Plastic Mulch on Plant Beds:

- 1. For plant bed treatment for new plantings, preplant incorporate 2 gallons (8 quarts) Devrinol 2-EC to a weed free soil before the laying of plastic mulch. Soil should be well worked yet moist enough to permit a thorough incorporation to a depth of 2 inches. Incorporate within 24 hours of application before laying of plastic mulch using equipment, which will result in uniform incorporation of the herbicide to desired depth. If weed pressure is from small seeded annuals apply 2 gallons (8 quarts) of Devrinol 2-EC on the surface of the bed immediately in front of the laying of the plastic mulch. If soil is dry, water or sprinkler irrigate with sufficient water to wet to a depth of 2 to 4 inches before covering with plastic mulch. Apply the plastic mulch over the treated soil the same day.
- 2. For application between rows of plastic mulch (middles or aisles), using a shielded sprayer or properly spaced drop nozzles, apply up to 2 gallons (8 quarts) per acre of Devrinol 2-EC on a broadcast basis to a weed-free soil surface between the rows of plastic. Mechanically incorporate or irrigate Devrinol 2-EC into the soil to a depth of 1 to 2 inches within 24 hours of application. In the event or emerged weed growth being present, tank mix up to 2 gallons (8 quarts) of Devrinol 2-EC with the correct amount of Gramoxone Extra to get burndown and residual control. Do not apply Devrinol 2-EC between bloom and harvest.

Use Directions

On flat-planted or bedded crops apply, before planting, to well worked soil that is dry enough to permit thorough incorporation to a depth of 1 to 2 inches. Incorporate within 24 hours of application, using equipment which will result in uniform incorporation of the herbicide to the desired depth.

After harvest or prior to planting of succeeding crops, a deep moldboard or disc plowing operation must be carried out.

To avoid injury, do not seed to alfalfa, small grains, sorghum, corn, lettuce or sugar beets for 12 months after Devrinol 2-EC application.

Tomatoes and Peppers (Direct Seeded and Transplanted)

Devrinol 2-EC can be applied and mixed (incorporated) into the soil before planting for weed control on seeded or transplanted tomatoes or peppers, or it can be applied as a surface application before laying plastic mulch. Devrinol 2-EC controls weeds by interfering with normal seed germination and seedling development. It does not control established weeds. All weed growth and crop stubble should be thoroughly worked into the soil before treatment. Refer to the list of weeds controlled.

The soil should be well-worked and dry enough to permit good soil mixing (incorporation). Pour the recommended amounts of Devrinol 2-EC into a spray tank during the filling operations.

IMPORTANT: In each case where a range of rates is given, the lower rates should be used on light (coarse) textured soils and soils low in organic matter. The higher rates should be used on heavy (fine) textured soils or on soils which experienced heavy weed infestation the prior year.

RESTRICTION: Make only one application per season.

All rates given below are broadcast rates. Reduce rates proportionately for band or strip treatment.

Apply ½ to 1 gallon (2 to 4 quarts) Devrinol 2-EC per broadcast acre.

Options for Tomatoes and Peppers (Direct Seeded and Transplanted) Grown in Beds with Plastic Mulch:

- 1. For incorporated treatments with plastic mulch, apply ½ to 1 gallon (2 to 4 quarts) Devrinol 2-EC per acre before bedding and incorporate. Use the higher rate for heavier soils and for soils which experienced heavy weed infestation the prior year. Apply to well worked soil that is dry enough to permit thorough incorporation to a depth of 2 to 4 inches, then form beds. Incorporate within 24 hours of application using equipment which will result in uniform incorporation of the herbicide to the desired depth.
- 2. For surface treatments where plastic is used, apply ½ to 1 gallon (2 to 4 quarts) Devrinol 2-EC as a surface application to the bed tops after bedding but before plastic application. Use

- the higher rate for heavier soils and for soils which experienced heavy weed infestation the prior year.
- 3. For use between beds where plastic mulch is used, apply 1 gallon (4 quarts) Devrinol 2-EC per broadcast acre as a surface application between beds. Rainfall and/or overhead irrigation sufficient to wet soil to 1 inch depth should follow treatment within 24 hours.

Tobacco (Transplanted)

Before transplanting, apply $\frac{1}{2}$ to 1 gallon (2 to 4 quarts) Devrinol 2-EC per broadcast acre. Use the lower rate on light soils (coarse textured - sandy) and the higher rate on heavy soil (fine textured - clay) and for soils which experienced heavy weed infestation the prior year.

TANKMIX COMBINATIONS

Tillam[®] 6-E Herbicide Combination – Tomatoes and Tobacco

A tankmix combination of Devrinol 2-EC and Tillam 6-E Herbicide can be applied and mixed (incorporated) into the soil before planting for weed control in tomatoes and tobacco.

IMPORTANT:

- Observe all cautions and limitations on labeling of all products used in combination.
- Make only one application per season.
- In each case where a range of rates is given, the lower rates should be used on light (coarse) textured soils and soils low in organic matter. The higher rates should be used on heavy (fine) textured soils and for soils which experienced heavy weed infestation the prior year.
- After harvest or prior to planting of succeeding crops, a deep moldboard or disc plowing operation must be carried out.
- To avoid injury, do not seed to alfalfa, small grains, sorghum, corn, lettuce or sugar beets for 12 months after application of Devrinol 2-EC/Tillam 6-E tankmix.

Existing stands of nutsedge must be turned under and chopped up thoroughly before treatment.

The recommended tankmix controls weeds by interfering with normal seed germination and seedling development. It does not control established weeds. All weed growth and crop stubble should be thoroughly worked into the soil before treatment.

Mixing Directions

Be sure the sprayer tank, boom and nozzle have been thoroughly flushed with clean water if another pesticide has been used previously.

Sufficient jet or mechanical agitation should be provided during the filling operation and during application. Fill the spray tank at least one-fourth full of clean water and while pump and agitator are

running, add the recommended amounts of the herbicides to the tank. Fill the tank with water to desired level. Do not allow the mixture to stand in the spray tank without agitation.

Allow the pump to run several minutes before application to insure proper suspension and mixing. The tankmix should not be left in the spray tank for prolonged periods; batches should be mixed and applied the same day.

Application Directions

The soil should be well worked and dry enough to permit good soil mixing (incorporation). Pour the recommended amounts of Devrinol 2-EC and Tillam 6-E into a spray tank during the filling operations. Apply in 25 to 50 gallons of water per acre.

For soil incorporated applications, use a properly calibrated, low-pressure, boom-type sprayer having good agitation.

In irrigated areas, do not apply before pre-irrigation. For all band applications, reduce dosage proportionately depending upon row spacing and band to be treated. Do not use on rocky ground because thorough incorporation is not possible.

Incorporation Directions

The herbicides must be mixed (incorporated) into the soil IMMEDIATELY after application to prevent loss by evaporation. Whenever possible, application and incorporation should be done in the same operation.

Incorporation Before Planting: Use power-driven cultivation equipment set to cut to a depth of two to three inches in coarse soils and three to four inches in heavy soils OR a tandem disc set to cut to a depth of six inches, followed by a spike-toothed harrow or some other leveling device which extends beyond ends of the disc. For thorough mixing, disc in two different directions (cross disc).

Incorporation At Planting: Use power-driven cultivation equipment set to cut to a depth of two to three inches OR, on coarse soils only, ground-driven tillers (rolling cultivators, rotary liou, row wheels, etc.) set to cut to a depth of 1½ inches and operated at 6 to 8 mph. When using ground-driven tillers, pre-cultivate if soil is crusted.

Planting

Crops should be planted or seeded immediately after application and incorporation. Do not use a drag behind the planter as it may concentrate the herbicides over the seed row and cause crop injury.

Cultural Practices Following Application

Shallow cultivation may be necessary to control those susceptible weeds that escape control as well as those weeds not susceptible to either herbicide. Do not cultivate deeper than the depth of herbicide incorporation.

When cultivating fields where the tankmix has been banded in the row, use shields to prevent the movement of untreated soil into the treated row.

Application Rate for Tomatoes [Direct Seeded (California Only) and Transplant]

Apply ½ to 1 gallon (2 to 4 quarts) Devrinol 2-EC plus 2-2/3 to 4 quarts Tillam 6-E per broadcast acre. Use the lower rates on light soils (coarse textured - sandy). Use the higher rate on heavy soils (fine textured - clay) and for soils which experienced heavy weed infestation the prior year. Do not use hotcaps on transplanted tomatoes.

Application Rate for Tobacco (Transplanted)

Before transplanting, apply ½ gallon (2 quarts) Devrinol 2-EC plus 2-2/3 quarts Tillam 6-E per broadcast acre.
