- 2. On page 1 use U.S. measure (pounds) for the Net Contents.
- 3. Revise the CONDITIONS OF SALE to be appropriate for a technical product:
 - a. Delete the second paragraph ("The Directions for use"
 - b. Change the third paragraph to read "United Phosphorus, Inc. warrants that this product conforms to the chemical description on the label and is reasonably fit for the purposes stated in the Directions for Use. - 5. Submit a Whole Sediment Toxicity Study for benthic invertebrates. Submission due by: December 2011.
- 6. Submit Aerobic and Anaerobic Aquatic Metabolism Studies. Submission due by: December 2011.
