- 1) On page 2 of your product label, revise the first sentence of your Environmental Hazards statement to read "This product is toxic to mammals, fish and aquatic invertebrates".
- 2) As part of the new 40CFR §158 Guidelines, an immunotoxicity study in rats and/or mice is required. You must submit or cite this study by April 2012.
