Application to Pad Mounted Electrical Sites to Reduce or Prevent Ant Mound Building Activity: uniformly distribute 1.0 to 1.5 tablespoons (0.06 to 0.09 lbs.) of UP-Star GC Granular Insecticide per 4 sq. ft. of mounting pad. If existing transformers are completely or partially filled with soil which has been excavated by resident ants, first remove any excess fill and level the remaining soil before application is made. If food utensils such as tablespoons are used to measure pesticide, they must not be used for food purposes afterwards.

Note: Ants are more attracted to electrical transformers in the Fall or early Spring. For best results, make application in these cooler months.
