Application Directions for Potting Media: Measure the dry weight of a unit volume of the mix to determine its bulk density. Based on the length of control required, thoroughly mix the appropriate quantity (see chart below) of UP-Star Nursery Granular Insecticide using equipment which will provide uniform distribution in the potting media. For more even distribution, consider premixing UP-Star Nursery Granular with an appropriate amount of sand (1:10).

UP-Star Nursery Granular is approved under the USDA Plant Protection Imported Fire Ant Quarantine Certification program when used in accordance with USDA guidelines. Use the recommended application rates given in the table below to obtain the length of control required for certification.

United Phosphorus, Inc. herein submits a registration amendment for UP-Star Nursery Granular Insecticide (EPA Reg. No. 70506-75) consistent with the notification provisions of PR Notice 98-10 and EPA regulations at 40 CFR 152.46.

This notification reflects the removal of the phrasing "for Commercial Use Only" from the front panel of the label. Per the US EPA Pesticide Labeling Consistency "For Use Only By" Issue Paper, dated October 24,2006 (see copy enclosed) this language is not enforceable and it is not appropriate to include on the label of a non-restricted use product any language limiting use to certified applicators. Therefore, UPI wishes to remove this phrasing from the UP-Star Nursery Granular label.
