Spray Volume: Apply TEBUZOL 3.6 F by ground in a minimum of 10 gallons of spray solution per acre or by air in a minimum of 5 gallons of spray solution per acre. Check equipment calibration frequently. For best disease control, complete coverage and uniform application are essential, especially when lower spray volumes are used. Use the appropriate spray volume to ensure complete coverage.

Chemigation: Do not apply this product through any type of irrigation system.

Mixing: Add recommended amount of TEBUZOL 3.6 F to the spray tank while filling with water to the desired level. Maintain agitation while mixing. If other materials are added to the spray tank, be sure that the TEBUZOL 3.6 F is thoroughly dispersed before other materials are added.

Compatibility: To determine the compatibility of TEBUZOL 3.6 F with other mixing partners, use the following procedure: Pour the recommended proportions of the products into a suitable container of water, mix thoroughly and allow to stand at least five (5) minutes. If the combination remains mixed or can be re-mixed readily, the mixture is considered physically compatible. For further information contact your local United Phosphorus, Inc. representative.

- Do not cultivate within 10 feet of an aquatic area to allow growth of a vegetative filter strip.

Spray Drift Management: For aerial applications, the spray boom should be mounted on the aircraft so as to minimize drift caused by wing tip vortices. The minimum practical boom length should be used, and must not exceed 75% of the wing span or rotor diameter.

Use the largest droplet size consistent with pest control. Formation of very small droplets may be minimized by appropriate nozzle selection, by orienting nozzles away from the air stream as much as



possible and by avoiding excessive spray boom pressure. Apply in a minimum of 5 gallons of spray solution per acre by aircraft spray equipment.

Spray should be released at the lowest possible height consistent with good pest control and flight safety. Applications more than 10 feet above the crop canopy should be avoided.

Make aerial or ground application when wind velocity favors on-target product deposition (approximately 3 to 10 mph). Do not apply when wind velocity exceeds 15 mph. Avoid applications when wind gusts approach 15 mph.

Risk of exposure to sensitive aquatic areas can be reduced by avoiding applications when wind direction is toward the aquatic area.

Low humidity and high temperatures increase the evaporation rate of spray droplets and therefore the likelihood of spray drift to aquatic areas. Avoid spraying during conditions of low humidity and/or high temperatures.

Do not make aerial or ground applications during temperature inversions. Inversions are characterized by stable air and increasing temperatures with height above the ground. Mist or fog may indicate the presence of an inversion in humid areas. The applicator may detect the presence of an inversion by producing smoke and observing a smoke layer near the ground surface.

CROP: Grasses Grown for Seed

General Directions: Apply TEBUZOL 3.6 F in at least 20 gallons of water/A by ground or in at least 10 gallons of water/A by air. For best disease control, apply in sufficient water for thorough coverage.

For best results, use the lowest recommended rate of a spray surfactant when tank mixing with TEBUZOL 3.6 F.

Do not apply more than 16 fl oz of TEBUZOL 3.6 F/A/crop season. Do not apply later than 4 days before harvest. The following may be used for feed: chaff, screenings, and straw from treated areas. It is prohibited to allow forage, cut green crop, or use of seed for feed purposes. Grazing is not allowed on regrowth until 17 days after the last application.

A tank mix with chlorothalonil at the rate of 12 ounces of active ingredient with TEBUZOL 3.6 F is effective to manage leaf spot resistance. No spray surfactant is necessary when TEBUZOL 3.6 F is tank mixed with chlorothalonil. Do not mixing or alternate TEBUZOL 3.6 F with other DMI fungicides as this may lead to the development of resistance.

Rainfall or irrigation carrying TEBUZOL 3.6 F into the root and pod zone is critical for control of root and pod rots caused by *Sclerotium rolfsii* and *Rhizoctonia solani*. If drought conditions exist, the effectiveness of TEBUZOL 3.6 F against the root and pod rots will be diminished.

Use TEBUZOL 3.6 F together with cultural practices (such as proper crop rotation) that are known to reduce the severity of soilborne diseases.

For best results, use the lowest recommended rate of a spray surfactant when tank mixing with TEBUZOL 3.6 F.
